To give you a better understanding of how I charge for work,  
I have 4 Cost Services:

- Individual Job Costings for requested jobs
- Monthly Fixed Rate Packages (Package 1)
- Monthly Fixed Rate packages (Package 2)
- Monthly Fixed Rate packages (package 3)

Monthly fixed packages can be invoiced out monthly or can arrange a weekly/fortnightly direct debit or automatic payment arrangement, this can be discussed at first consultation.

Monthly fixed packages can be discussed and tailored to fit your company/Trust requirements.

I have broken everything down into a standard fee structure. Our fees are based on the time I spend working on a job, but we also use this standard fee structure as a guideline on what final fees should look like.

Apart from the charge out rates and Xero fees, which are fixed, the other prices are indicative and depend on the accuracy of files and documentation provided, the volume and complexity of transactions and the speed and frequency with which you respond to requests for information.

- **My current charge out rates for accounting services are:**
  - Accountant \$80 phr
- **Xero subscription fees are:**
  - Ignite \$35 per month
  - Grow \$75 per month
  - Comprehensive \$99 per month
  - Ultimate \$113 per month

(Note that these are based on Xero's published prices and can be updated accordingly)
- **Filing returns :**
  - Income tax returns \$150 per return plus time spent working on a job.
  - GST returns \$150 per return plus time spent working on a job
  - Company office annual returns \$250 for filing & Admin Fee
- **Financial reports :**
  - Sole Trader Accounts \$500 – \$700 per Report
  - Company and Partnership Financial Statements \$1,500 – \$3,500; per year.
  - Provisional tax reviews/reminders and tax pooling arrangements : \$175 per provisional tax instalment.
- **Payroll**
  - Setup of Payroll- one-off fee \$150
  - Processing of Payroll- Fixed fee per week- \$60 per pay run
  - Inputting/Updating of Employees details/ timesheets/Deductions- Accountants hourly fee as above.
  - Prices may vary depending on size of company and employee numbers.
- **Invoicing-**
  - Setup of Hub doc- Free
  - Approving and coding bills to pay- Accountants hourly fee as above, max 2 hrs
  - 20<sup>th</sup> of Month Batch payments - Accountants hourly fee as above, max 1 hrs
- General tax and business advice is complimentary if signed up on a package deal , if signed up on an individual plan this is complementary for 2 consults after which it is charged out at a fixed rate, see pricing tables
- All the above prices exclude GST.

Pricing options include paying as the work is done, in which case the above fee structure will apply, or if you use our monthly fixed price packages, it works out to be roughly 30% cheaper for you. Fixed price quote for the packages listed or for a customized packages can be discussed at first Consultation meeting.

If I give you an estimate, it is an estimate and not a fixed price quote, a one-off startup fee is required of \$300 + GST for setup and paid 7 days after signing contractual agreement and first months fixed fee to be paid on the 20<sup>th</sup> of following month or as agreed upon.



**Monthly fixed package deals, or if package deals are agreed upon this will be itemised within contractual agreement.**
